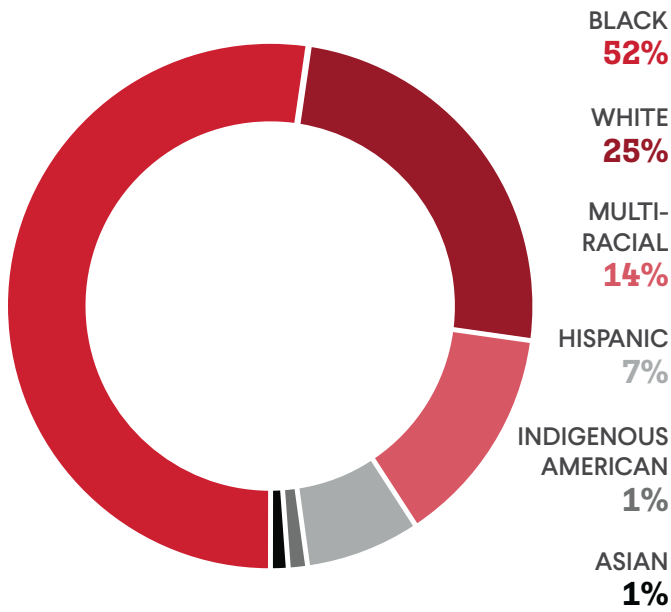

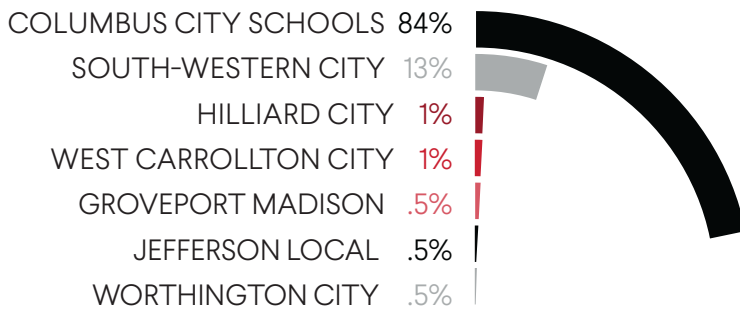

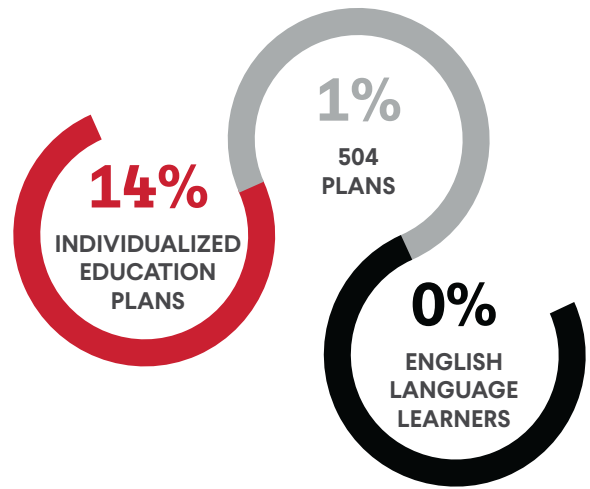

ACADEMIC PROGRESS

The academic goals of Central Point Preparatory Academy during the 2022-23 school year were to meet or exceed expected growth in Reading and Math as measured by the i-Ready assessment and Ohio State Test (OST).

Central Point Preparatory Academy achieved these goals as evidenced by the 3-star rating on Progress for meeting state expectations in Grades 4-7 and exceeding expectations in Grade 8 on the OST. Additionally, i-Ready diagnostic results show growth in reading and math, primarily for students who were 1-2 grade levels below in the fall but were on or above or just one level below by spring.

YOY PERFORMANCE INDEX SCORE



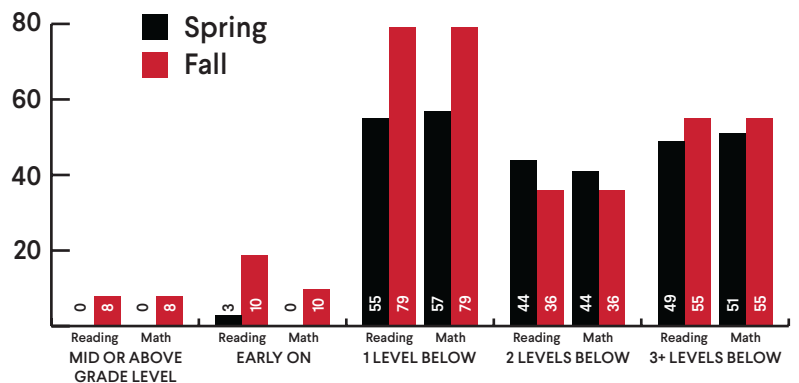
